**General Terms and Conditions:-**

1. The quotations should reach in the office of the undersigned on or before 16-07-2018 up to 4 pm and the same shall be opened at Authority Level Rate Contract Committee meeting on 18-07-2018 at 2 pm.
2. The material should be strictly as per prescribed specifications.
3. The rates for supply of material should be FOR Bhadarwah inclusive of all taxes, damages if any occurred during transportation the dealer/agency/firm shall personally responsible.
4. Taxes as admissible under rules shall be deducted.
5. The agency should have the PAN card/GST.
6. The supplier shall need to mention CMC rates for five years which shall be applicable after warranty/guaranty period, along with quotations. The L1 bidder shall be arrived at, on the basis of cumulative rates of items and CMC rates for five years i.e A+B, where (A) is the rate of items inclusive of all taxes FOR Bhadarwah and (B) is the CMC rates per year for five year after the completion of warranty/guaranty period.
